Fictional document, produced for demonstration. **This letter does not say no to the landlord: it tells him how.** That is what makes it acceptable, and what protects the agency.

Body of the letter

Dear Sir,

You have told us your preferences for selecting the tenant of your property. We cannot build our shortlist on applicants' family situation, or on where their guarantor lives: these do not measure the ability to pay rent, and a selection resting on them would engage our liability as much as yours.

We therefore present the nine files that meet our solvency criteria, each with the ratio of income to rent, the nature of the employment contract and the guarantor's strength judged on their income.

The choice among these nine is yours, and you need not justify it. We remain at your disposal to discuss it.

Four blank reasons out of six lettings. A blank reason protects nobody — not the applicant, who will never know, nor the agency, which will have nothing to produce. The field can be made required at closure, with a list of lawful reasons **and a free-text field that stays free.**
