The three consistency checks

Check	Result	Action taken
Identifier consistent with the previous file	Discrepancy	Declared change of registered office or typing error — both documents side by side, the officer settles it in ten seconds

A discrepancy is never settled by the agent: it is presented with both documents and the scheme's rule in plain terms. **The ceiling compared is that of the version of the rules in force**, with the resolution that sets it and its effective date.

The summary handed to the applicant

The full check took four minutes, against 25 minutes in the back office. **The applicant knows the same day what is missing** — that is the difference between a file being tracked and a file being waited on.
