Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **Each draft is built on the registry template matching the nature of the case. The clerk checks, authenticates and serves — and it is that act which gives the document its force.**

What each draft carries, and where it comes from

Item	Content	Source
Mandatory particulars	Reproduced verbatim	Registry templates — no line written by the agent
Interval between summons and hearing	Calculated case by case: all 31 comply	2 complied only by a single day — flagged before sending

The two points flagged without being asked

Observation	What the agent does	What it does not do on its own
Street number missing from an address	It gives the exhibit in the file where the address appears in full	It does not complete the address on its own initiative
Illegible address line on an exhibit	It gives the second exhibit in the file carrying the same address	The registry settles the address used

Last year, 74 summonses came back for want of an exact address, and each one cost an adjournment or a service of process. Checking at the point of preparation removes the cause, not the symptom.

The time this moves

Step	Before	After	Who does it
Preparing the summonses for a hearing	2 hours	12 minutes of checking	The registry checks, authenticates and serves
Across 38 hearings a month	—	63 registry hours a month	Given back to assisting at hearings

The next step proposed: the drafts build themselves as soon as the list is set, the evening before, **and wait at the registry the next morning. The principle is approved once; every hearing then arrives with its summonses ready.**
