Fictional document, produced for the demonstration. **A schedule that merely alarms is worth nothing**: for all six files, the step to be taken is prepared and awaits the registry's check.

The six deadlines, in order of expiry

Pre-trial preparation is the stage during which the case is prepared, exhibits are exchanged and the file becomes ready for judgment. **The exhibit that starts a deadline running is the one you look for when that deadline is disputed six months later — it is on every line.**

An adjournment means three to six more months for court users who are already waiting. It is the figure that speaks to the parties rather than to the service, and it is the one that has moved most.
