## The drafting rule, and why it protects the court

## What that changes for the parties

**Six days on an appeal deadline is not service comfort: it is time given back to the party to decide what to do.**

**The evening record waits in draft and goes out in one click to the presiding judge and the hearing registry. Across last month's 38 hearings, it would have won eight days for each of the 17 chains of steps a hearing triggers.**
