Generic or named: two regimes, both workable. A *contact@* address belongs to the company; a named address identifies a person and the GDPR applies in full. **In both cases the source notice appears in the message.**

What was not done

No extraction from a directory or a professional network. Database law prohibits extracting a substantial part of a protected database, and those platforms' terms prohibit it as well. **The 500 lines come from company websites, press rooms and public registers, consulted one by one.**
