The rule that holds the figure: a value not read is not written, it is requested. **Over the quarter: 58 missing values, 58 requests prepared for their recipient, 52 answers back within eight days.**

Protection of the signature: across **1,004 outputs** over two quarters, **1,004 were validated by a person**, and **the 68 reworks were all done before dispatch, none after. The 7 particular cases of the second quarter became 7 more templates, already written** — three of them for the incentive waste charge the authority is introducing next year.
