The state of the document store

Finding	Volume	Consequence
Pieces indexed	3,120	9 years of archives
With no usable file name	940	Those are the ones you look for on a Friday evening
Duplicate versions	268	Risk of starting again from an outdated version
"Looking for a document", quarterly timesheets	26 h	More than three working days across eleven people

Indexing renames nothing and moves nothing. Your current paths keep working: the agent adds a reading, it does not reorganise your document store.
