Seven can stay within the week, seven move by a fortnight. The table says which is which; it does not say which ones can wait. That question is clinical and has no column.

The two messages, ready and unsent

Version A — moved within the same day. "Hello, your appointment on Thursday 13 August has been moved to with Dr Diallo, at the same practice. If that slot does not suit you, reply to this message."

Version B — moved by a fortnight. "Hello, your appointment on Thursday 13 August cannot go ahead. The first available slot is If your situation cannot wait, please call us on"

Version B carries a sentence version A does not: it invites the patient to call back if the wait does not suit. That is not politeness — it is the only route by which an unsuitable reschedule can find its way back to the practice.
