Article L1111-7 of the French public health code. The five years run from the date the information was created — not from the last consultation. A single record can therefore fall under both limits, document by document.

In the case shown, two documents date from 2019: the two-month limit applies to those, the eight-day limit to the rest. The practice may answer in two stages, provided it says so.

What the agent does with this request

It records the date of receipt, works out the applicable limit document by document, alerts two days out, and flags to the head of reception what is coming due. **It hands over no document and sends none:** releasing the record is an act of the practice.

Scope of this document: the service operated by Blue Lemon Agent. For an agent deployed at your premises, the applicable location is that of the architecture set out in the quotation and verified before commissioning; local execution is announced only for the configuration explicitly described and accepted in the quotation; the applicable isolation depends on the deployment mode set out in the quotation, no dedicated isolation being presumed; the encryption mechanisms in transit and at rest, their components and key management are those documented for the architecture chosen; roles and permissions are configured and accepted for the identities and systems actually connected; the events logged, their content, their retention period and who may access them are defined for the deployment chosen.
