Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **The agent has written all 7 updated versions**, each aligned on the resolution in force, **with the replaced line and the line replacing it side by side. The municipality reads them, corrects with a word and settles the version — and it is that signature that makes the template enforceable against a resident who would challenge it.**

What the 34 templates produce each year

Three templates out of thirty-four produce 204 of those 385 documents — the temporary roadworks decree (96 a year), the village hall agreement (61) and the planning letter (47). **Revising those three first means handling more than half the output in twenty minutes of approval.**

These 7 gaps existed before the agent. They only show up when the template and the register of resolutions are put side by side — **and nobody had the time, because this work is only visible when it has not been done.**

The action that stops it happening again

When	What the agent does	What is left to the municipality
The day after each council meeting	It flags any template amended by that evening's resolutions, and writes its updated version	Reading it and settling the version
On request	It costs what the updated version would have changed over the past year, document by document	Bringing it into service, signed — it takes a word
