Fictional document, produced for the demonstration. **A wrong sheet does not show: it reads perfectly well and it does not work.** The comparison is with the configuration actually in force, not with the document's last modification date.

The 96 sheets the configuration made wrong

What those 96 sheets cost, measured

Finding	Volume	Consequence
Tickets citing one of the 96 sheets	430	Over the past year
of which a second call from the same person within 48 h	118	It was not a shortfall of skill: the procedure had aged
Sheets approvable in under a minute	74 out of 96	Replaced line and replacing line set side by side
Sheets carrying a choice of procedure	22	Two wordings proposed, each with the number of tickets it would have covered

What the agent now does after every change

Event	Delay	What is produced
Migration, update or configuration change	The following night	Up-to-date version of every affected sheet, awaiting reading
Equipment withdrawn from the estate	The following night	Affected sheets flagged and corrected
Routing corrected by a technician	Immediate	The wording enters the table — a correction made once is never made again

It is this rule that took reopenings from 12.4 % to 2.1 % from one quarter to the next. It costs the department no more than one reading per configuration change.

Wording retained for the 22 sheets carrying a choice of procedure: _____

Scope of this document: the service operated by Blue Lemon Agent.
