Fictional document, produced for the demonstration. **Exclusions are set by the sales director; the agent only applies them** — without exception and without arbitration. Every removed line carries its grounds and its date, so that an exclusion can be challenged and lifted.

The four grounds for removal

What matching on company number prevented

An exclusion is not a door closed for life. If an excluded contact fills in the website form again, **they are put back on the list with the date and the page on record**, and the sales administrator is told. Someone who comes back of their own accord has changed their mind: it is theirs to say, and the agent's to hear.

A costed proposal awaiting a decision: lower the automatic removal threshold from €20,000 to €8,000 of open quotation. **It would cover 61 more deals a year and would cost 61 unsent follow-ups.** The ratio between those two numbers is the only argument that matters here, and it is given so that the decision takes one minute.
