Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **This is not a general delegation: it is a written mandate, bounded by four cumulative conditions, capped in amount, dated and withdrawable on a word.**

The four cumulative conditions

Condition	Why it bounds the mandate
Sick leave under 30 days	Beyond that, the duration calls for judgement
Group scheme with no amendment under way	An amendment under way changes the applicable cover
Every document gathered	A missing document takes the claim out of the mandate
No point of medical judgement	One single point, and the claim goes back to the medical adviser

Over the past year, 3,240 of the 8,560 claims met those four conditions, and the medical adviser granted every one — 3,240 times out of 3,240. The mandate creates no new decision: it removes six days of waiting on a decision whose outcome is known.

The cap, and the choice it leaves

Benefit cap per claim	Claims covered	What happens above
€2,500 — proposed	3,240	The claim goes back to the medical adviser
€4,000	3,890	The claim goes back to the medical adviser

The four other bounds

Bound	Proposed value	Reason
Duration	6 months	Renewal needs a signature — stopping does not
Statement	Every morning, on one page	A mistake is caught in an hour, not in three weeks
Withdrawal	One word, effective within the minute	Claims go back to draft for approval, nothing else changes
Review	On the 15th of the sixth month	Set in the diary on signature

What the mandate earns

Gain	Value
Claims granted on the day of filing	3,240, instead of 6 days
Medical adviser time given back	1,300 hours, moved to the 5,320 complex claims
Effect for the member	Paid in the week he needs it

The decision belongs to the compliance department and the medical adviser

— and it is taken on a text that is already written, with one signature. The regime starts the day after signature.
