Activity code	Appears on no document	Ask the supplier
Purchase family	Belongs to your taxonomy	A management choice
Managing department	Belongs to your organisation	A management choice
Payment method	Not agreed at this stage	A decision
Payment terms	Not agreed at this stage	A decision

The activity code could be inferred from the company name, and it would be right nine times out of ten. The tenth is what costs: a rejected payment order, a misfiled supplier, and nobody left to remember the field was guessed.
