Fictional document, produced for demonstration. **Only one of the four is handled urgently.** A stale citation is a debt; a contradiction between two orders in force is an immediate risk.

The fourth has no legal effect and is handled anyway. Eleven spent texts sitting in the register read as eleven texts in force: the defect is not in the law, it is in what the resident believes on reading.

The later act often prevails in practice, but not always: the first may cover a use the second did not mean to remove. That is read in the intention, which lives in the resolutions, and not in the dates.

Four acts kept by the signing authority — the 2019 contradiction, meanwhile, is on the desk with both texts

The act, kept by the signing authority	Why it is theirs
--	------------------

Repeal an act	An act is repealed by a signed act
Name the order that must fall	Intention is outside the agent's field of view
Write an unread citation	A wrong citation looks like a correct one
Remove a text from the register	A register whose texts disappear can no longer be relied on
