The State representative refers to the administrative court the acts it considers contrary to legality within two months of their transmission — **article L2131-6 of the general code of local authorities**.

What this tracking does not say

Question	The tracking's answer
Will the prefect refer this act?	The tracking has no idea
Is the act lawful?	The tracking has no idea
Can a third party still challenge it?	Yes — and that does not depend on this window

A point few authorities use: on request, the State representative informs them of an intention not to refer an act that has been transmitted. The same article provides for it — and it has to be asked for, act by act.
