This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. **No characteristic is guessed.** When a value is missing from the PIM, the line stays empty and reads « to be completed »: **a guessed value is indistinguishable from a measured one once it is written down** — and it is the guessed one that ends up in a customer specification.

Found along the way, and worth more than the pages: 38 discrepancies between what the PIM says and what the manual for the same reference says. They are raised, none has been settled — arbitrating between two technical sources is a company decision, and it is written once for all 340 references.
