What makes a translation dependable — and what stays to be signed

What stays your decision	What the agent hands you to decide with
Translating statutory wording or a company name	The 34 documents where the legal form was rendered as "Ltd" are listed, 11 of them contracts: a legal form changes meaning when it changes legal system, so the agent leaves it intact and shows you where it was touched
Deciding which version prevails	The 7 documents with no clause are identified, 3 of them already signed, and the clause reaches you already drafted: it is a contract clause, it is negotiated
Translating from a translation	The agent goes back to the original: across the 41 cascaded translations, 9 departures in 12 checks — each pass adds its approximations
Enriching the glossary	The 47 divergent terms are proposed to you, written out; whoever maintains the glossary settles them, and the 312 terms already drafted are finally connected to the translation
Producing a certified translation	The translation is ready and annotated, passage by passage: certification requires a person and their liability, and the sworn translator has only to review it instead of redoing it
Settling a doubtful passage	Every hesitation is noted at the exact spot: a translation with no notes reads as certain, and that is where disputes start
