The second flag goes out on the day of publication, not when somebody notices it. On an incumbent contract the first days serve to decide whether to fight — and that decision requires assembling four years of delivery.

What the agent guarantees on every notice

What the agent guarantees	What you gain
Every notice arrives with its submission date, its documents and what it demands	The decision to bid is taken knowingly, against your workload and your references — and it takes minutes
The notice's criteria are set against your references, one by one	You see where you are strong and where a document is missing; the assessment belongs to the buyer, but you no longer discover it at the opening
The file is assembled, complete, and waiting to be submitted	Submission commits the company: it takes one gesture, at the moment you choose, and the chase moves to 4 hours as soon as under 3 days remain
Notices are ordered by submission date, with their requirements in plain words	A score would make people skip the reading: here you read three lines and decide, with no figure deciding for you
