Fictional document, produced for the demonstration. **The sort judges no content:** a document is superseded when the register designates a later version. An effective date and a publication number are enough — which is what makes this table indisputable in an audit.

What the platform does, and what it does not

Action	Done by the platform?	Effect
Stop serving the document as a reference	Yes, automatically	Nobody lands on 4.1 without knowing it
Place the banner "superseded on ... by ..."	Yes, automatically	Reversible if the register is corrected
Prepare the removal batch by space and by owner	Yes	4 minutes for 38 documents on the two spaces already handled
Remove or delete a file in the source	Never	The platform works read-only — deletion is irreversible and touches contractual proof

The result obtained without touching a file: the 1,260 superseded documents are no longer served as references, and each one names its replacement. **The administrators' pass no longer catches a mistake: it tidies a base that is already safe.**
