Zero out of nine is not a repeated oversight: it is the absence of a circuit. No variation was carried over, which shows nothing provides for them to be — and that no amount of individual diligence will change it.

Automatic copying would be technically trivial and practically dangerous: a file fed by a tool without anyone knowing where the value came from is a file nobody checks any more.
