When the answer is not in the retailer's content, it is not invented: the request goes to an adviser with what has been checked, and the question joins the list of articles to write. **Over the year, 4,900 questions took that route, and 187 became articles.**

A monthly re-run of the 1,240 articles against publications, terms and conditions and product sheets is proposed, with the gaps and the rewrite already done. The base then stops ageing in silence.
