Fictional document — demonstration example

This document is produced by the Blue Lemon Agent website to illustrate what an AI agent hands to its users. The companies, matters, amounts and people in it are invented. It has no legal, accounting or commercial value.

Fictional document, produced for the demonstration. *A goodwill gesture is a credit, a partial refund, free delivery or a voucher granted to close a complaint: it commits the retailer's money, so it is decided.* **This mandate is written, capped, dated and withdrawable on a word.**

The four reasons covered

Reason	Gestures granted in the year	Advisers' decision
Delivery more than 5 days late	18,400	Granted in 100 % of eligible requests
Installation slot missed	11,900	Granted in 100 % of eligible requests
Parcel received damaged with a photo	7,600	Granted in 100 % of eligible requests

Reason	Gestures granted in the year	Advisers' decision
Delivery charges wrongly billed	3,300	Granted in 100 % of eligible requests
Total	41,200	41,200 out of 41,200

The mandate creates no new decision: it removes two days of waiting on a decision whose outcome is known, and which your advisers already take systematically.

The two caps

Cap	Proposed value	Gestures covered	Above it
Amount per case	€40	33,800	The request goes to an adviser
Amount per case — other option	€60	38,100	The request goes to an adviser
Volume per customer	1 gesture per quarter	—	The second goes through an adviser: a customer who complains twice is asking a question that is no longer commercial

The three other bounds

Bound	Value	Reason
Duration	3 months	Renewal needs a signature — stopping does not
Statement	Every morning, reason by reason and amount by amount	A regime that drifts shows in a day

Bound	Value	Reason
Withdrawal	One word, effective within the minute	Every gesture goes back to an adviser, nothing else changes

What the mandate earns

Gain	Value
Complaints closed within the conversation	33,800, instead of a 2-day wait
Adviser hours given back	13,100 h, moved to the complaints that need arbitration
Average cost of a gesture	€34 → €26 — a credit granted on the day costs less than a credit granted after three chases

The decision belongs to the customer relations department — and it is taken on a text that is already written, with one signature. The regime starts the next day, the review is set for the 15th of the third month.
